## How Does It Affect Me?

### **Coding Changes effective 2012:**

If you are submitting claims electronically, the new version 5010 electronic claims standards must be in use by **July 1, 2012**. Make sure your software is up to date!

**How does it affect you?** The biggest change is that all provider address data will be required to show the new zip+4, and you cannot list a PO Box as a clinic address. Not sure what your zip+4 is? Look it up on [www.USPS.com](http://www.USPS.com) under zip code lookup.

New diagnostics codes (ICD-10) go into effect **October 1, 2013**. No need to worry about those yet!!

## Workers' Compensation

**Want to file a lien? Check to see if there is an open ADJ case? Need a PR-2 or PR-4 form?** The state of California Department of Industrial Relations has a great user-friendly website to help you with all your questions. Don't use your old "green lien" forms—these are no longer in use. All forms are available online. Go to:

**EAMS** is a computer-based case management



system used by the California Division of Workers' Compensation to file forms and documents with the DWC. Forms can be filed online or by mail using the EAMS OCR paper forms, found at the DIR website listed above.

*Medicare will be sending revalidation requests to providers over the next two years. If you registered with Medicare prior to March 2011, you will receive a request from Medicare to revalidate. Don't delay! If you do not revalidate quickly you risk losing your ability to bill Medicare claims.*

## Medicare EHR Incentives

Medicare has started the EHR meaningful use incentive program. Below is the website where providers can register to create an attestation statement which tracks your progress in attaining "meaningful use" of EHR.



Whether you start in 2011 or 2012, you can receive up to \$18,000 for your first year. Medicare will pay you an incentive of 75% of your allowable Medicare charges for the given time period, up to \$44,000 over 5 years. Check into it!
